Enrollment Due: April 27, 2020 at Midnight

POSSESSION

- Take possession of animal on or before mandatory possession date listed on the *Livestock Requirement Summary*.
 - All animals with a May 1st possession will be postponed to June 1st.

WEIGH-IN/TAGGING/TATTOOING

- Attend Pre-Fair Weigh-In/Tagging/Tattooing at the Knox County Fairgrounds.
 - **Market Beef/Market Dairy Steer** – December 7, 2019 from 8:00 to 11:00 a.m.
 - **Beef Feeder** – June 6, 2020 from 8:00 to 11:00 a.m.
 - **Dairy Market Feeder** – June 6, 2020 from 8:00 to 11:00 a.m.
 - **Market Hogs** – See *Livestock Requirement Summary*
 - **Market Lambs** – June 6, 2020 from 8:00 to 11:00 a.m.
 - **Market Goats** – June 6, 2020 from 8:00 to 11:00 a.m.
 - **Market Rabbits** – June 27, 2020 from 8:00 to 11:00 a.m.
