NEW!!! Acknowledgment of USDA Support by NIFA

Proper acknowledgment of your USDA-NIFA funding in published manuscripts, presentations, press releases, and other communications is critical for the success of their agency's programs.

When acknowledging USDA support grantees must use the following acknowledgment for <u>all competitive projects or initiatives</u> supported by the National Institute of Food and Agriculture (NIFA): "This material is based upon work that is supported by the National Institute of Food and Agriculture, U.S. Department of Agriculture, under award number XXX-XXXXX-XXXXX."

When acknowledging <u>USDA</u> support for capacity grants, use the following language: "This material is based upon work that is supported by the National Institute of Food and Agriculture, U.S. Department of Agriculture, [insert project type, e.g. Hatch/Evans-Allen/McIntire Stennis project] under [insert accession number]."

Whenever practical, NIFA also expects that grantees use NIFA's official identifier in publications, posters, websites and presentations resulting from their award.

In addition, all <u>publications and other materials</u>, except scientific articles or papers published in scientific journals, must contain the following statement: "Any opinions, findings, conclusions, or recommendations expressed in this publication are those of the author(s) and do not necessarily reflect the view of the U.S. Department of Agriculture."

Press Announcements and Media Interviews

Recommended awards should not be announced in any manner by a grantee until approval is obtained by NIFA's communication office. This applies to press releases, newsletters, and press interviews, web or social media postings. In many cases, the Secretary of Agriculture may want to personally announce the award.

NIFA grant awardees are requested to coordinate all public announcements with NIFA's Communication Staff at CommunicationsStaff@nifa.usda.gov (link sends e-mail). Simultaneous announcement by NIFA and the grantee are preferred.

The awardee is responsible for acknowledging NIFA support during news media interviews that discuss work supported by NIFA.

NIFA Request for Application Schedule

NIFA's Office of Grants and Financial Management have established a Request for Application (RFA) Schedule that includes anticipated dates of publication for the remaining FY2015 RFAs. NIFA does not guarantee that the RFAs will publish by these dates. This schedule is for informational purposes only and will be updated on a biweekly basis.

Faculty Achievements & Recent Awards

A team of Ohio State researchers are continuing their cross-disciplinary study of the molecular effects and chemopreventive potential of natural foods such as black raspberries on human oral cancer development, thanks to a grant from the National Institutes of Health (NIH) for five years for \$3,122,815 to Examine the impact of black raspberries on oral cancer. Chemoprevention is the use of chemical agents, drugs or food supplements to prevent or inhibit the development of cancer. The researchers are examining the impact of black raspberries on smokers and non-smokers, and how bacteria in the mouth respond to the black raspberries as a trigger or cue. Christopher Weghorst, (Environmental Health Sciences) is the principal investigator. Co-investigators are Steven Clinton, (Medical Oncology), Thomas Knoblock, (Environmental Health Sciences), Purnima Kumar, (Periodontology), Dennis Pearl, (Statistics and Biostatistics), Steven Schwartz, Yael Vodovotz and Kenneth Riedl, (Food Science and Technology).

Sudhir Sastry, Mohammad Shavezipur (FABE) and **Ahmed Yousef** (Food Science and Technology) received \$240,000 from Cornell University for *Microfluidics and physics based approaches to elucidate physical mechanisms of fresh produce contamination.*

Shelly Dee Jepsen (FABE) was awarded \$79,396 from the Ohio Bureau of Worker's Compensation for *Understanding the safety and health risks of stored grain facilities on Ohio's farms, with a strategy for prevention.*

Please note that in an ongoing effort to maximize profit opportunities for Ohio soybean farmers, the OSC Board of Trustees has decided to consider proposals for checkoff funding every quarter on a rolling basis. This differs from the past, where proposals were requested only once per year. Going forward OSC will request proposals each quarter, and contractors will have the opportunity to present good ideas for projects as they arise during the year. For the current quarter, proposals received by the deadline of Friday, August 7, 2015 will be considered by the OSC Board at the September Board meeting.

Accelerator Awards for Inventors

Accelerator Awards, sponsored by the Technology Commercialization Office (TCO), Office of Research and Rev1 Ventures (formerly TechColumbus), provide Ohio State researchers with a small amount of capital to further develop and validate inventions, software and technologies. Awards of up to \$50,000 are granted twice each year and are available to all Ohio State faculty, postdoctoral and graduate student researchers who have disclosed their inventions to TCO. **DEADLINE: Ongoing**

Searle Scholars Program This program awards \$100,000 per year for three years of support to researchers pursuing careers in biochemistry, cell biology, genetics, immunology, neuroscience, pharmacology, and related areas in chemistry, medicine and biological sciences. Candidates should have begun their first appointment as an independent investigator at the assistant professor level on or after July 1 of the year prior to the application year. There are generally 15 awards made per year, with the application portal opening in September of each year.

Science Foundation Ireland is accepting nominations for the St. Patrick's Day Science Medal. The medal is awarded annually to a distinguished Irish scientist, engineer or technology leader living and working in the USA. The medal will recognize individuals who are not only outstanding in their fields of expertise but who also have demonstrably assisted researchers in Ireland in either academia or industry – via mentorship, supervision, collaboration, industrial development, entrepreneurship etc., or who have made significant contributions to developing the research ecosystem in Ireland.
