### Document Description:

The series of emails show communication from 2015 to 2016 around a future vision for Greene County for a federal grant providing a Federally Qualified Health Center (FQHC) in Greene County. The communication exchange was between the Health Commissioner, Fiver Fivers Health Care Centers CEO, and the VP of a local hospital system. In consideration of applying for this opportunity, public health surveyed provider practices and analyzed the data to assess gaps in access from our existing health care system. Results revealed limited access to health care resources, especially for the uninsured. We know that the major challenges affecting Greene County Ohioans include maternal-child health, chronic disease and behavioral health. There are numerous emerging issue that cause barriers including affordable health care services, affordable housing, limited and affordable transportation, poverty and high unemployment.

#### **Agenda & Discussion**

**Other Discussion points:** Need to provide 40 hours of primary care from March to July 2017. Need provider... physician? NP? Where to locate clinic? Can we provide clinics in evening- we may get 40 hour capacity with that plan. We will need 9-10 exam rooms for capacity. What about a temporary trailer? There will be a quota of clients required. Grant will receive 10 pnts extra for being a sparsely penetrated area. To get 5 extra points, we need to know if we have a sparsely placed population. (meaning it is not near many health care opportunities). Total grant points=100.

## Five Rivers Health Centers Proposal to Collaborate with Greene County Public Health To Create a Federally Qualified Health Center in Greene County

Five Rivers Health Centers (FRHC) was established on May 23, 2011 as a medical home for low-income residents of the greater Dayton region. In November 1, 2013, FRHC was awarded a 330 HRSA grant and became a Federally Qualified Health Centers (FQHC). FQHCs are community-based organizations that provide comprehensive primary and preventive care to people of all ages, regardless of their ability to pay, while helping patients to establish medical homes.

FRHC has 8 locations—Family Health Center, Center for Women's Health, Medical Surgical Health Center (houses the 340B Pharmacy), Dental Center, Pediatrics, Samaritan Homeless Clinic, and Specialty Clinics (2 locations). Specialties not included under the FQHC umbrella (out of Scope) include Neurology, General Surgery, GI, Orthopedics, Hand Surgery, and Infectious Diseases. FRHC is the 9<sup>th</sup> largest FQHC within Ohio.

FRHC proposes to create a FQHC within the current/future space of the Greene County Public Health (GCPH). FRHC will lease the space allocated for medical and dental portions of the building. FRHC will absorb the staff and contracts associated with the following clinics: Immunization Clinic- Childhood/Adult, Flu Clinics, Prenatal Clinic, Male and Female Reproductive Health Clinic, Child and Adolescent clinic, and Dental Services. FRHC proposes to lease all of the employees associated with these clinics from the GCPH for the first 6 months after the FQHC has been created. After that time period, the leased employees will become employees of Five Rivers Health Centers. In addition, FRHC is committed to finding a full-time provider to provide comprehensive primary and preventive care services at this location. The services not provided by FRHC will continued to be referred to the GCPH (i.e. WIC, SW, etc.). Patients will continue to be seen regardless of their ability to pay by using a sliding fee scale. FRHC will provide the electronic medical record –EPIC – for use at the center.

In the past 10 years, the Health Resources Services Administration (HRSA) has created the opportunity for a New Access Point (NAP), a new Federally Qualified Health Center application, four (4) times –2008, 2012, 2014, and it is estimated November, 2015. FRHC would recommend submitting an application. The costs associated with writing the grant application will be absorbed by FRHC. Five Rivers Health Centers is requesting a letter of intent from Greene County Public Health in order to proceed in submitting a FQHC application.

## Overview of the FQHC Application for Five Rivers Greene County Health Center process:

- Submitted preliminary application – June 8<sup>th</sup> -- see attached Project Abstract
- Final application – due July 15<sup>th</sup>, will submit July 7<sup>th</sup>
- Space – the new FQHC will remain in the GCPH space even during the construction
- Providers – Current Contracts – FRHC will honor the current contracts of all of the KHN providers – *Action Item: Letter of Commitment from KHN on behalf of these providers or signed contracts to include in the application*
- Full-Time Provider – We would like to hire a FRHC physician or NP to be employed. When FRHC does hire a NP, we would like to have a Collaborating Agreement with one of their physicians if possible. If we are unsuccessful in finding a candidate, we will work with KHN to find a provider.
- FQHC Requirements – we need a Transfer Agreement with KHN for patients need to be admitted, x-ray, lab, referrals for specialties etc. Please see attached Transfer of Agreement as a reference point. *Action Item: Letter of Support to include in the application supporting the requirements above. We can draft a letter*
- EPIC –There is a significant EPIC build needed to added the Medicaid and Medicare FQHC Prospective Payment System within the Prelude (Registration) and Resolute (Billing) sections within EPIC. Need to determine how we can calculate our unduplicated patients and all of our quality measurements across both EHRs. – *Action Item: A representative from the KHN IT team to help with this project to help bridge this gap with PH IT team to create data that can be used for billing and federal reporting purposes. We would like to include preliminary EPIC budget numbers to bring EPIC live within the new FQHC.*

**Organization, Community to be Served, and the Target Population**

Five Rivers Health Centers (FRHC) opened May, 2011 in Dayton/Montgomery County, Ohio. FRHC is a 501 (c)(3) non-profit corporation and was approved for recognition as a Federally Qualified Health Center (FQHC) Look-Alike in April, 2012. On November 1, 2013 FRHC received HRSA Section 330 (e) FQHC funding status. Five Rivers Health Centers consists of three (3) former hospital residency clinic departments – Family Health Center, Medical Surgical Health Center, and Center for Women’s Health. In 2013 the group expanded even more by adding a Pediatric practice in January and in September added the Five Rivers Dental Center and a 340b In-house Pharmacy. In August of 2015, FRHC experienced additional expansion by adding the Samaritan Homeless Clinic. FRHC aims to improve the total well-being of Greene County’s most vulnerable population with incomes <200% the Federal Poverty Level (FPL) consisting of four (4) ZTCAs: 45385, 45314, 45335, and 45324 with a total low-income population of 32,268.

**Major health care needs and barriers to comprehensive primary health care services**

In the proposed service area there is limited access to health care resources, especially the uninsured. The major challenges affecting Greene County Ohioans include: heart disease, diabetes, hypertension, multiple respiratory concerns, oral health disease, cancer, mental illness and substance abuse. There are numerous barriers including: affordable health care services, affordable housing, very limited and affordable transportation, poverty, and high unemployment. Currently, Greene County, Ohio does NOT have a community health center (CHC) located within the county, leaving low-income and uninsured Ohioans without access to CHC services.

**Patients, visits, providers, delivery site/location, services to be provided**

FRGCHC will provide a continuum of care for Greene County’s vulnerable population of all ages living less than 200% of FPL. By December 31, 2018 FRHC will provide comprehensive health care services to 1,800 unduplicated patients, within a medical home setting, while producing 4,746 visits. FRHC will employ 1.3 FTE medical; 0.6 FTE dental; and 0.5 FTE behavioral health provider staff. The satellite health center- Five Rivers Greene County Health Center (FRGCHC), will be centrally located at 360 Wilson Dr., Xenia, OH 45385. The new access CHC will provide required and additional services while extending accessible hours of operation. FRGCHC will offer primary and preventive medical care including Family Medicine, Internal Medicine, OB/GYN, Pediatrics, and Dental. Enabling services such as coordinated case management, transportation, insurance/Medicaid enrollment assistance, etc., will be provided. Through collaborative relationships, referrals to specialty services will include Adult Transitional Sickle Cell, Infectious Diseases, Gastroenterology (GI), General Surgery, Hand Surgery, Hematology/Oncology, Mental Health, Neurology, and Orthopedics – Surgical. In 2015, FRHC’s served over 20,800 patients with 73,684 visits in the adjacent Greater Dayton community.

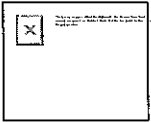

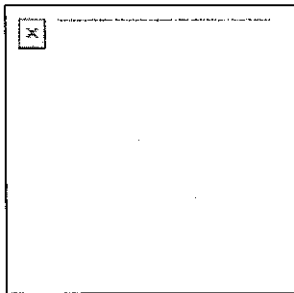

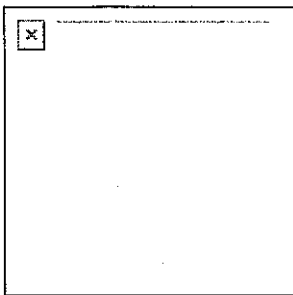
