ONLINE DUNF COMPLETION

General Rule 26 (page 7 of 2019 Fairfield County Junior Fair Rule Book) states:

The DUNF must be completed and signed before the animal is unloaded (for weigh-in). Market animals and any species that requires a DUNF must be free from any/all drugs in their system on fair weigh-in day.

The following species must complete a separate DUNF for **each** animal:

- Dairy Beef Feeders
- Lactating Dairy Cows
- Market Beef (steers and heifers)
- Market Hogs & MQP Barrows
- Market Lambs & MQP Lambs
- Lactating Dairy Goats
- Market Goats
- Market Poultry (1 DUNF per pen of Poultry)

Market Rabbits DO NOT need to complete the DUNF.
