What is a campership? A campership is a scholarship designed to assist 4-H youth who may not have an opportunity to participate in the Fulton County 4-H Camp at 4-H Camp Palmer. It is funded by the Fulton County 4-H Endowment Fund.

What does a campership provide? A campership will assist a 4-Her with registration fees for 4-H Camp. Scholarships will be awarded based on family financial need, completion of the campership application and completion of the Club Volunteer reference form.

Application Process:

- **1.** To be eligible for a campership, applicants must be enrolled in the Fulton County 4-H Program. Campers must be at least 8 years old and in the third grade OR 9 years old and no older than 13 years of age by January 1 of the current year.
- **2.** To apply, submit the attached completed application including a short essay. Applications are due to the Fulton County OSU Extension Office by April 15 at 4:30 p.m.
- **3.** Hand your 4-H leader the 4-H volunteer reference form. Have the <u>club leader</u> complete and return to the Fulton County OSU Extension Office by April 15 at 4:30 p.m.
- 4. Late applications will not be considered.
- **5.** Scholarship funds will only be awarded to the individual named on the application.
- **6.** Priority will be given to youth who demonstrate financial need.
- 7. \$3,000 have been allocated for camperships. Campership amounts will be determined based on the number of applicants and financial need. Camperships may be approved for varying amounts; full scholarships may be available.
- 8. Notifications will be emailed by May 1.
