It also requires Israeli military police to 'make a reasonable attempt' to determine the residency status of a person if there is a reason to suspect that he or she is an illegal immigrant.

An Israeli military spokesman, Lt. Col. Avital Leibovich, said it would help the military to drive illegal immigrants from the nation, saying, "This law protects every Israeli citizen from a dangerous and unacceptable situation."
