**Health Requirements**

Measles/Mumps/Rubella	Completion of vaccination series or immunity confirmed by positive titer.
Varicella	Completion of vaccination series or immunity confirmed by positive titer.
Hepatitis B	Completion of vaccination series and immunity confirmed by positive titer.
Tetanus/ Diphtheria/ Pertussis	Tdap vaccination within 10 years of start date of the rotation.
Tuberculosis	Initial 2-step PPD or Quantiferon test prior to the start of the P1 year, and screenings completed yearly thereafter. Most recent screening in Spring 2021.
Seasonal Influenza	Vaccination to be completed after 8/1/2021 and by 10/1/2021. Student shall provide documentation upon request.

**Other Requirements**

Drug Screen	Negative results for a 14-panel drug screen performed at the OSU Student Health Center, Spring 2021.
Criminal Background Check	BCI/BFBI criminal background check showing no felony convictions, performed by a licensed vendor of the Ohio Attorney General's WebCheck system.
OIG Review	An inquiry of the Office of Inspector General's (OIG) Cumulative Sanctions website was completed.
HIPAA Training	Annual completion of OSU trainings including HIPAA and Infection Prevention (Clinical) regulations.
BLS	Active Basic Life Support (BLS) for Health Professionals certification or an equivalent through April 2022.
Immunization Training	Completion of the APhA Pharmacy-Based Immunization Delivery Certification in April 2019.
General Liability Insurance	Student is covered by the <i>Student in Practicum</i> general liability insurance coverage provided by The Ohio State University for all academic activities, in the amounts of no less than \$1,000,000 per occurrence and \$3,000,000 in the aggregate. A certificate of insurance is available upon request.
Health Insurance	Student must maintain active health insurance coverage and shall provide documentation upon request.
Ohio Pharmacy Intern License	Student must maintain active Ohio pharmacy intern licensure in good standing and shall provide documentation upon request.
