#### A.G. Kawamura

He is co-chair of Solutions from the Land, a non-profit organization that is currently working to organize and convene the North American Alliance for Climate Smart Agriculture. The Alliance will collaborate with farmers, ranchers, foresters and stakeholders to implement climate smart land management practices and strategies. He also serves on several boards and committees including: The AGree Initiative; the Board on Agriculture and Natural Resources (BANR), a policy arm of the National Academy of Sciences' Natural Resource Council; Ag Advisory Committee for the Chicago Council on Global Affairs; American Farmland Trust; 25x'25, a national alliance of renewable energy stakeholders; UC Davis Agricultural Sustainability Institute (ASI) external advisory board. He is a former chair and current board member of Western Growers Association. As a progressive urban farmer, AG has a lifetime of experience working within the shrinking rural and urban boundaries of Southern Calif. Through his company, Orange County Produce, LLC, he is engaged in building an exciting, interactive 21st century 100-acre agricultural showcase at the Orange County Great Park in Irvine, CA.

#### Bill Dawson

Bill Dawson has devoted his lifetime to teaching others about his love of gardening and nature, and inspiring people of all ages and backgrounds by his passion and enthusiasm for this work. Bill has worked at Franklin Park Conservatory and Botanical Gardens for over 24 years, and has been leading the Conservatory's Growing to Green Community Garden Program since 2000. Bill has helped to grow the number of community gardens in Columbus from a dozen to more than 250 in just 16 years. Today, thanks to Bill's help, the City of Columbus has more thriving community gardeners per capita than any other major metropolitan city. Bill manages the award-winning, state-of-the-art Scotts Miracle-Gro Community Garden Campus located at Franklin Park Conservatory. This world-class resource system serves as a national model for community gardening, outreach and education.

# Bill Lynch

Bill received his bachelors and masters degrees from The Ohio State University in Fisheries Management in 1980 and 1982, respectively. During his 30 years at OSU, Bill participated in a wide variety of research projects during his 18 years in the School of Environment and Natural Resources, including wetlands, reservoir and riverine management, and aquaculture. He also spent 12 years as an Aquatic Ecosystem Management Specialist with the OSU Extension program, helping private pond, lake, and

wetland owners properly manage their water bodies. In 2007-2012, Bill was the University's lead educator on Harmful Algal Blooms (HAB's) occurring throughout Ohio, educating both public and private water pond & lake managers on HAB's: causes, health threats to humans, and remedial actions to control and prevent blooms. Bill retired from OSU in 2012 but has remained active, particularly in aquaculture. Bill started his vellow perch pond culture facility in 2001 and sells all sizes of perch to pond and lake management companies. Bill is currently President of the Ohio Aquaculture Association. He also chairs the Industry Advisory Council of the USDA's North Central Regional Aquaculture Center and serves on the Center's Board of Directors. Bill still actively teaches and does 20-25 aquaculture presentations annually in Ohio and other north central states on yellow perch, water quality and disease prevention, aquaculture BMP's, marketing, sustainability, pond management, and aquaculture cooperatives. Bill is currently a PI on a USDA Grant awarded to The Ohio State University and the Ohio Aquaculture Association titled "Aquaculture Boot Camp Two", commonly referred to as ABC-2. The goals of this project are to provide intensive information and technology transfer to 30-35, selected beginning aquaculturists and aquaponists annually to enhance their potential to develop successful business endeavors. Participants meet for a full day each month to obtain biological, marketing, and business knowledge so they can develop a viable business plan, a requirement to being selected for the program.

## Bill Tom

Bill Tom is the Executive Vice President of Livestock Marketing for United Producers, Inc. based in Columbus, OH. Prior to this current role, Bill worked with Trupointe Cooperative, Cargill Inc., Church & Dwight Co., Inc. (Arm & Hammer Brands), and Alpharma Animal Health. Throughout his career, he has generated an intense appreciation for the agricultural sector, with a particular expertise in livestock, grain, and environmental preservation. In addition to his work with United Producers Inc., Bill is a member of the Governor's appointed Ohio Soil & Water Conservation Commission, the Chair of the Public Policy Committee within the Ohio Agri Business Association, and the Department Director of the Ohio State Fair Beef Department. He has previously served as the Board President of the Alpha Gamma Rho Alumni Board (Professional Agricultural Fraternity), a past Board Member of the Ohio Soybean Association, a past member of the U.S. Grains Council, and a former Board Member of the Ohio Shorthorn Breeder's Association. Bill graduated from The Ohio State University with a B.S. in Animal Science. He is a devoted husband and father of four children, and grandfather to one beautiful granddaughter.

## **Bobby Moser**

Bobby Moser served as Vice President and Dean of The Ohio State University's College of Food, Agricultural, and Environmental Sciences from 1991 to November 2012. Born in Cyril, Oklahoma, Bobby Moser earned his B.S. and M.S. degrees in Animal Science and Nutrition at Oklahoma State University in 1965 and 1969, respectively. He earned a Ph.D. in Animal Nutrition at the University of Nebraska in1972. Moser is nationally recognized and is credited with the development of scientifically sound and sustainable programs, while incorporating ecological ethics and technological innovations. His developments in the field continue to influence and drive the future of agriculture in the United States and around the world.

#### **Brian Snyder**

Brian Snyder is executive director of the Initiative for Food and AgriCultural Transformation (InFACT) at The Ohio State University, a position he has held since June 1, 2016. InFACT pursues holistic approaches to ensure good food for all. Its work is based on collaboration across the sciences, engineering and humanities, as well as the engagement of external partners in government and private industry. As such, he is addressing challenges along the entire value chain from field to fork, with an aim to ensure the future health of farms, the environment and consumers alike. Previously, and for over 15 years, Brian served as executive director of the Pennsylvania Association for Sustainable Agriculture (PASA), which is considered one of the largest and most effective sustainable ag organizations in the United States. During his tenure, PASA membership grew from about 1,000 to nearly 6,000 individuals. Before moving to Pennsylvania, Brian was executive director of The William J. Gould Associates, which operates Gould Farm, a 700-acre sustainable farm and mental health treatment facility in the Berkshire Hills of Western Massachusetts, known to be America's oldest therapeutic community of this type. Brian holds two masters' degrees, from Harvard University (Theological Studies) and the Isenberg School of Management (Business Administration) at the University of Massachusetts at Amherst. In addition to writing and speaking in a number of venues on the subject of sustainable agriculture, Brian serves on several other related boards, including as the Immediate Past President of the Pennsylvania State Council of Farm Organizations. He also serves in an advisory capacity for the Resnick Program for Food Law & Policy at UCLA in Los Angeles.

## **Brian Williams**

Brian Williams has been an agricultural specialist working with the Mid-Ohio Regional Planning Commission since May 2009, focusing on farmland preservation and promoting local foods in central Ohio and around the state. Before that, he had a 25-year career in journalism in five Ohio cities and two other states, focusing on local food, land use, planning, farmland preservation, urban revitalization, transportation and regional cooperation. He also spent three years as Ohio State Director of American Farmland Trust before coming to MORPC.

# **Casey Hoy**

Casey Hoy joined The Ohio State University as an Assistant Professor of Entomology upon completion of his graduate work at Cornell University in 1987, and was promoted to Associate Professor in 1993, and Professor in 1998. The former Associate Chairman of the Department of Entomology, he has held the Kellogg Endowed Chair in Agricultural Ecosystems Management and provided leadership to the Agroecosystems Management Program of the Ohio Agricultural Research and Development Center since 2006. Prof. Hoy's past research has included systems analysis and its application to integrated pest management and applied ecology. His current work provides interdisciplinary leadership toward advancements in agroecosystem health and sustainable communities. He currently leads the Ohio State University Discovery Themes Initiative for Food and AgriCultural Transformation, InFACT, an investment of more than \$100 million over the next 10 years in resilient and sustainable food security, including 30 new faculty hires across the University. Prof. Hoy teaches graduate level courses that include systems analysis and quantitative methods in environmental research. He has received the OARDC Multidisciplinary Team Research Award, OARDC Distinguished Faculty Research Award, and the ESA Award for Excellence in Integrated Pest Management. He has served on many federal grant review panels, the

Ohio Food Policy Advisory Council, several boards of trustees and the executive committee for the Kellogg endowed Inter-institutional Network for Food and Agricultural Sustainability.

# **Charlie Eselgroth**

Charlie is a full time, lifelong farmer of 40+ years. He operates an 800-acre organic dairy, grass fed beef, and crop farm. His family has been farming organically for 20 years, with the last couple of fields currently in transition, and these last fields will be certified organic in the summer of 2018. The farm currently employs 5 young people, some full time, some part time, all eager to learn about agriculture, all interested in having their own operation someday. Charlie currently serves on the Dairy Executive Committee of CROPP / Organic Valley Cooperative, representing the Southwestern Ohio/Central Indiana region. In the past, he has served on the local Soil and Water Board, his church board, and the local Boy Scout troop. Charlie was a founding member of Innovative Farmers of Ohio, and a founding member of the Chillicothe Farmers Market.

# **Chris Henney**

Chris Henney joined the Ohio AgriBusiness Association in May 2011 as the president and chief executive officer. OABA is a membership-based state trade association that can trace its history to 1880. Originally founded as the Ohio Grain Dealers Association, OABA members today include manufacturers, wholesalers and retailers of plant nutrient and plant protection products, the grain warehousing and marketing industry, the feed industry and the seed industry, as well as companies providing equipment, financing, insurance, consulting, and other products and services for the agribusiness industry. Chris has been involved in Ohio agriculture for most of his life and is excited about leading OABA into the future. Prior to joining OABA, Chris held several positions at the Ohio Farm Bureau Federation, most recently as the director of legislative relations. #### Dave Lipstreu

Dave's professional background is in public sector land use planning. He worked as Planning Director for a city near Cleveland, Ohio for many years. During that time, he was also extensively involved with regional water quality management planning under Section 208 of the Clean Water Act (PL 92500, as amended), as well as working closely with regional metropolitan planning organizations (NOACA and NEFCO) on this endeavor. He served as a trustee of the Chagrin River Watershed Partners during which time he worked on watershed planning and the drafting and subsequent adoption of sustainable development regulations into Aurora, Ohio's Codified Ordinances. This also included the development and adoption of one the first riparian zoning ordinances in the state of Ohio. Additional responsibilities included serving as chairman of the Portage

County Regional Planning Commission, and as a member of the Newbury Township Zoning Commission. Dave is currently, and has been for many years, a member in good standing of the American Institute of Certified Planners, the American Planning Association, and the Ohio Chapter of that organization. Presently he is working on forest preservation issues with the Ohio Chapter of the Sierra Club, specifically on the Shawnee State Forest. ## **David Hanselmann**

David Hanselmann is a Lecturer and the Environmental Professionals Network (EPN) Coordinator at The Ohio State University, School of Environment and Natural Resources. Each semester he teaches the School's capstone course for seniors majoring in environmental science, environmental policy, and natural resources management. Each May he also teaches a four-week all-day, every-day field trip-based course, Conservation Planning and Practices – Ag and Urban. In 2012 Hanselmann established the EPN, now with nearly 1800 professionals across Ohio plus OSU students, faculty and staff networking online. The EPN also features diverse monthly breakfast programs averaging over 135 attendees, mainly from outside the University. Many programs are focused on sustainability and agriculture. Prior to joining the OSU faculty in 2011, Hanselmann served for many years as Chief of the Ohio Department of Natural Resources' Division of Soil and Water Resources. There he assisted Ohio's 88 soil and water conservation districts and implemented a wide range of agricultural, water and land resources, environmental, and education programs, both regulatory and assistance-based. He also established many cooperative programs with NGOs, local, state, and federal agencies, the private sector, and academia. During his final two years at ODNR he concurrently served as Chief of the Division of Recycling and Litter Prevention. He holds a B.S. in biology/ecology from Purdue University and an M.S. in ecology from Duke University.

#### **David Orr**

David W. Orr is Paul Sears Distinguished Professor of Environmental Studies and Politics and senior adviser to the president of Oberlin College. He is a founding editor of the journal Solutions, and serves as the executive director of the Oberlin Project, a collaborative effort of the city of Oberlin, Oberlin College, and private and institutional partners to improve the resilience, prosperity, and sustainability of Oberlin. Orr is the author of seven books, including *Down to the Wire: Confronting Climate* Collapse (Oxford, 2009) and coeditor of three others. He has authored nearly 200 articles, reviews, book chapters, and professional publications. In the past 25 years, he has served as a board member or advisor to eight foundations and on the boards of many organizations, including the Rocky Mountain Institute and the Aldo Leopold Foundation. Currently he is a trustee of the Bioneers, the Alliance for Sustainable Colorado, and the Worldwatch Institute. He has been awarded seven honorary degrees and a dozen other awards including a Lyndhurst Prize, a National Achievement Award from the National Wildlife Federation, and a Visionary Leadership Award from Second Nature. Orr is a frequent lecturer at colleges and universities throughout the United States, Europe, and Asia. While at Oberlin, he spearheaded the effort to design, fund, and build the Adam Joseph Lewis Center, which was named by an AIA panel in 2010 as "the most important green building of the past 30 years," and as "one of 30 milestone buildings of the twentieth century" by the U.S. Department of Energy.

Ernie Shea is the Founder and Principal of Natural Resource Solutions (NRS), LLC. NRS designs, organizes and implements national and regional sustainable land use initiatives which deliver renewable energy, climate change, biodiversity, economic development as well as soil, water and air quality solutions and improvements. Joe is a 5th generation family farmer from Northeastern Ohio, and has owned and operated Logan Brothers Ag Enterprises since 1977. The farm has specialized in producing a variety of products including milk, beef, grains and maple syrup. He still actively farms in partnership with his brother, specializing in grass fed beef, non-GMO grain, and organic crops. Joe currently serves as the President of the Ohio Farmers Union (OFU), and he previously served in the same role for a 6-year term between 2001-2007. He also served as the OFU Director of Governmental Relations before serving as the Director of Agricultural Programs for the Ohio Environmental Council (The OEC) from 2008-2013. Joe currently sits on the Board of Directors of the National Farmers Union (NFU) where he serves as the Chairman of the Legislative Committee and a member of the NFU Executive Committee. He also serves on the Board of Directors of the Organization for Competitive Markets (OCM), and the Coalition for a Prosperous America (CPA), where he serves as the Agricultural Co-Chairman. He has represented the OFU and the OEC on the Ohio Food Policy Council and the Ohio Phosphorus Task Force, a multi-agency taskforce convened to study water quality impacts from phosphorus runoff. Some of Joe's other appointments include President of the National Association of Farmer Elected Committees (NAFEC 1998-2001) representing the interests of the locally elected Committees in the Farm Service Agency offices nationwide; board member on the Board of Directors of Dairy Farmers of America (DFA 1997-2000) and its predecessor Milk Marketing Inc. (MMI 1992-1997); President of the Harpersfield Vineyard LLC (1997-2005); and several terms as president of local and county school boards (1987-1999).
